ACRONYM INSTITUTE ANNUAL REPORT FOR 2021 from Dr Rebecca Eleanor Johnson, Executive Director

The Acronym Institute for Disarmament Diplomacy (AIDD) is a UK-based not-for-profit civil society organisation with United Nations consultative status through ECOSOC. With international reach based on over twenty-five years of work on ecofeminist alternatives to militarism, insecurity and inhumane weapons, AIDD provides research, ideas and practical strategies to promote and strengthen humanitarian security and disarmament agreements, environmental sustainability and gender equity to enable the full and safe engagement of women in building peace, human rights and security for all. During 2021, AIDD received core funding from the Joseph Rowntree Charitable Trust (JRCT) and a portion of the JRCT grant to UNA-Scotland for coordinating UK work on the UN Treaty on the Prohibition of Nuclear Weapons (TPNW). AIDD's Board of Directors, personnel and institutional arrangements in 2021 remained essentially the same as reported in 2020.

AIDD's years of work on nuclear disarmament were brought forward when the TPNW entered into force on 22 January 2021. Building on this, AIDD's work this year sought to broaden understanding and engage with governments, diplomats and civil society actors to build more effective engagement across a range of security, environmental and justice issues, with emphasis on reinforcing international humanitarian law and the United Nation's Sustainable Development Goals (SDG). In that regard, our work in 2021 particularly related to SDG 16 on disarmament, SDG 5 on gender equality, SDG 11 on safe cities, and SDGs 13, 14 and 15, relating to climate change and supporting sustainable, healthy and biodiverse life on land, in the air and under water.

Though institutionally quite small, AIDD has continued to carry out an effective schedule of online meetings and presentations focussing on using the TPNW and other treaties to take forward security objectives to prevent nuclear war, eliminate nuclear arsenals, and limit the risks and impacts of environmental destruction and militarism. Along with nuclear abolition, AIDD work this year encompassed restricting developments, proliferation and inhumane uses of conventional explosive armaments, small arms and light weapons (SALW), and automated weapons systems aka 'killer robots'.

AIDD continued to work closely with the International Campaign to Abolish Nuclear Weapons (ICAN), including through the participation of Rebecca Johnson, Janet Fenton and Board Member Gari Donn as members of ICAN's International Steering Group (ISG), and by coordinating ICAN partners meetings in the UK and networking with other European and international civil society. As the TPNW entered into force, AIDD raised awareness through billboards and meetings in Scotland, and various briefings and events with faith leaders, parliamentarians and mayors, scientists, youth and students, including universities and schools.

Considerable work over the year went into researching and writing AIDD's detailed analysis on the TPNW and British nuclear policy. The report, titled 'Nuclear weapons are banned: What does this mean for Britain?' was produced with support from CND, the Nuclear Information Service and Nuclear Education Trust. Its online launch took place in

January 2022, as the Tenth Review Conference of the Non-Proliferation Treaty (NPT) was postponed due to UN concerns about Covid.

The TPNW's entry into force focussed AIDD's work on the treaty's implementation, including verification and institutional issues for the first meeting of States Parties, scheduled for a year after January 2021 (but subsequently postponed for several months). AIDD's work also centred around developments relating to the Westminster government's Integrated Review on Security, Defence, Development and Foreign Policy published by the Cabinet Office in March 2021, climate talks leading up to and including COP 26 (26th Conference of Parties to the UN Framework Climate Convention, held in Glasgow in November 2021), and 40th anniversary events for the Greenham Common Women's Peace Camp in September. These milestones increased media attention, public interest and meetings in Britain and with international civil society online. Despite cancellations and postponements of some diplomatic conferences due to Covid, AIDD speakers were able to coordinate work and present our information and ideas at a wide range of online events and meetings, many of which attracted bigger and more international audiences than could have participated in person. These included events with parliamentarians and peace and environmental activists in Scotland, the South-South Forum on Sustainability, Futurefest online talks with ICAN participants such as executive director Beatrice Fihn, PeaceChild event with military speakers on the TPNW and British responsibilities, SOAS seminar on Feminist Leadership in Disarmament, and various WILPF events on nuclear weapons and militarism, conscientious objectors and environmental protectors. AIDD's 2021 Annual Report provides fuller details.

To mark the 40th anniversary of the Greenham Common Women's Peace Camp, AIDD coordinated and hosted a series of webinars. These included: 'Feminist Disarmament and Treaty-Building', with Hiroshima Hibakusha Setsuko Thurlow, Ambassador Elayne Whyte-Gomez, President of the TPNW negotiations, Dr Patricia Lewis (Chatham House) and others; 'Pacific Women Say 'No' to Nuclear Colonialism', with Vanessa Griffin (from Fiji, PANG's representative on ICAN Steering Group); Chailang Palacios (Northern Marianas), Lisa Natividad (Guahan /Guam), Corazon Valdez-Fabros (Philippines) and Zohl de Ishtar (Australia); 'Feminist Peace, opposing violence, militarism and war' with Dr Hannah Safran (Women in Black Haifa), Lepa Mladenovic (WiB Belgrade), Dr Vanessa Ludwig (Cape Town) and others; 'Western Shoshone Speak Out Against Nuclear Colonialism', with Indigenous Shoshone speaker Ian Zabarte and others, talking about the impacts of the Nevada Test Site, British and American nuclear testing and nuclear waste on Newe Segobia lands and the human rights of downwinders and Western Shoshone people.

Janet Fenton has continued to work closely with AIDD Board Member Dr Gari Donn in Scotland and publish relevant articles with Reaching Critical Will and nuclearban.scot. Dr. Natalie Goldring has continued to serve in the leadership team of the International Action Network on Small Arms (IANSA) and UN meetings on behalf of AIDD, also contributing to advocacy work, briefing papers and other materials for diplomats and civil society on implementing the Programme of Action on Small Arms and Light Weapons, and the Arms Trade Treaty. AIDD speakers contributed to various publications and a wide range of media coverage in 2021, including BBC TV and radio, ITN, Times Radio, Channel 4, Sky News and various podcasts. AIDD analyses were featured in articles published by IDN (In Depth News, the UN-based International Press Syndicate), the Guardian, OpenDemocracy, Bella Caledonia, the National, Labour Hub and Peace News, amongst other international,

local and online platforms. AIDD research was also featured in various news stories, broadcasts, publications and leaflets on nuclear, climate and human security issues. As inperson meetings are being reinstated, AIDD plans to continue to hold and encourage online meetings and participation for reasons of costs, climate impacts, energy resources, and public and personal health and energy. Dr Johnson was the founding president of ICAN's Swiss establishment from 2010, and currently serves as Secretary.
