# ACRONYM INSTITUTE ANNUAL REPORT FOR 2018 prepared by Dr Rebecca Johnson, Executive Director

#### 1. Summary

The Acronym Institute for Disarmament Diplomacy is a UK-based not-for-profit civil society organisation with UN consultative status through ECOSOC. With international reach based on over twenty years of work on nuclear and humanitarian issues and treaties, Acronym provides research, ideas and practical strategies to promote and strengthen humanitarian disarmament and security agreements, environmental sustainability and progress for women, peace and security.

Following the UN General Assembly negotiations and adoption of the 2017 Treaty on the Prohibition of Nuclear Weapons (TPNW), 2018 has been a year of consolidation, outreach and awareness raising. Having played a central role in achieving this Treaty and then sharing in the 2017 Nobel Peace Prize awarded to the International Campaign to Abolish Nuclear Weapons (ICAN), Acronym's Executive Director Dr Rebecca Johnson and Communications Manager Clare Conboy were joined in 2018 by Janet Fenton on ICAN's international steering group (ISG) in 2018, where we contributed to strategies and decisions for bringing the TPNW into force and using the Nobel award to enhance awareness of all aspects of humanitarian security and disarmament. Acronym continued to co-coordinate the Management group for ICAN partners in the UK, with enhanced public outreach, especially in Scotland.

Acronym was funded in 2018 by the Joseph Rowntree Charitable Trust, with priority given to three areas of our work:

- raising awareness about the 2017 Treaty on the Prohibition of Nuclear Weapons and facilitating its entry into force;
- supporting international disarmament and humanitarian security objectives, with emphasis on treaties that reinforce international humanitarian law and the United Nation's sustainable development goals (SDG); and
- work on enabling the UK to comply with the disarmament and non-proliferation
  provisions of the Non-Proliferation Treaty (NPT) and take the necessary steps to join the
  TPNW -- this work focussed in 2018 on building support for the TPNW in Scotland and
  holding meetings where feasible in other UK areas to raise awareness of the
  humanitarian and financial costs and problems of the Dreadnought nuclear submarines
  and Trident programme.

Acronym's team also participated in international and UK-based workshops and coalitions addressing women, peace and security, establishing a zone free of weapons of mass destruction (WMD) in the Middle East, and conflicts and military activities that undermine global humanitarian security, the SDGs, UN Charter and international law.

In addition to this brief summary, our work is evidenced by the meetings, media, written and audiovisual materials and publications listed below in sections 2-5 of this annual report. As

described there in more detail, Acronym was involved in a wide variety of events and activities in 2018. These included meetings in the Westminster and Scottish Parliaments, town halls, universities, colleges, schools, trades unions, Parliamentary Committees, the UK Defence Academy, and local civil society and faith-based groups in Britain and Ireland, at which Rebecca Johnson, Janet Fenton and Clare Conboy talked about nuclear and humanitarian challenges, Britain's existing legal and security obligations under the NPT and the new provisions that will take legal effect when the TPNW enters into force, highlighting the impacts for British security. We also provided briefings for the UN Office for Disarmament Affairs, and participated in meetings with governments and NGOs attending the NPT and UN First Committee meetings in Geneva and New York in 2018.

Coordinated by Janet Fenton, Acronym has continued to provide briefings and advisory opportunities for engagement with the Scottish Parliament and Government, building on relationships made through Scotland's UN House as well as other civil society organisations, and taking into account the opportunities and challenges of raising nuclear and security issues within Scotland's devolved administration. Janet Fenton played an initiating role in establishing the Scottish Round Table to explore opportunities for civil society and academic engagement with the TPNW, nuclear warhead convoys and Trident-related activities. As well as her central role in coordinating ICAN partners in Scotland and speaking at local and parliamentary meetings, Janet Fenton co-organised and enabled Acronym's full participation in meetings in Glasgow and Edinburgh during the year, including the international gathering at Faslane in September 2018. These events provided opportunities for ICAN and other international and British experts to establish connections with Scottish academic researchers and civil society partners along with parliamentarians and civic leaders.

In addition to nuclear weapons, Acronym has continued to support the UN SDGs. Work on SDG 16.4 has been led by Dr Natalie Goldring in her capacity as Acronym's Director of Conventional Arms and Trade. Dr Goldring continued in 2018 to work closely with the International Action Network on Small Arms (IANSA) in its global outreach and work to implement the Programme of Action (POA) on Small Arms and Light Weapons (SALW). While serving on the Leadership Team for IANSA, Dr Goldring contributed to briefing papers and training sessions for diplomats as well as civil society meetings in the United States on issues ranging from the 'Doomsday Clock and the Ban Treaty' to the arms trade and peacebuilding through disarmament. On behalf of Acronym and IANSA (of which Acronym is a partner), Dr Goldring presented on 'Synergies between the PoA and other key instruments' at the March 2018 meeting for the Third Review Conference on the Programme of Action on Small Arms and Light Weapons, held at the United Nations in New York. Dr Goldring subsequently delivered the IANSA statement to the UN First Committee in October on 'Partnering with civil society to enhance efforts to control small arms and light weapons'. In her work with the Arms Trade Treaty Dr Goldring also serves on the Rapid Response team of Control Arms. Three of Dr Goldring's publications in 2018 related directly to her conventional arms work on behalf of the Acronym Institute.

Dr Johnson's publications in 2018 focussed mainly on US-Korean nuclear issues, in conjunction with her participation in the International Panel on Fissile Materials meetings in Seoul in April and then with 'Women Cross DMZ' and Nobel Women's Initiative in Seoul and the Demilitarized Zone (DMZ) in May. By contrast, Clare Conboy's audiovisual publications spanned a wide range of military challenges, from nuclear weapons to fully autonomous weapons systems (a.k.a 'killer robots'), publishing interviews with Acronym and other spokespeople for ICAN and the Campaign to Stop Killer Robots (CSKR).

Board membership remained the same in 2018, comprising David Atwood (Chair), Professor Christine Chinkin, Advocate Nomi Bar Yaacov and Lord David Ramsbotham. Further details can be found in the Acronym Institute's 2018 Annual Report.

Rebecca Johnson was employed for 2.5 days per week from January, increased to 3.5 days per week from 15 December 2018. Clare continued as a full time employee of the Acronym Institute until end November 2018, but from 13 August 2018 she carried out some consultancy work with the Campaign to Stop Killer Robots (CSKR), by agreement with Acronym Institute, which is a partner in the CSKR network. Clare was subsequently offered a full time position with CSKR as their Geneva-based Media and Communications Manager, and formally terminated her employment with Acronym Institute on 6 December 2018, after receiving our agreement that she could waive the usual notice and join staff meetings with CSKR in Washington DC in December. Natalie, who receives an academic salary in the United States, has continued to represent Acronym at UN and other meetings relating to conventional arms control and the Arms Trade Treaty. In March, Janet Fenton became an alternate representative for Acronym on ICAN's International Steering Group (ISG), supporting our work at the UN and in Scotland.
