1. Summary

The Acronym Institute for Disarmament Diplomacy (AIDD) is a UK-based not-for-profit civil society organisation with United Nations consultative status through ECOSOC. With international reach based on over twenty-five years of work on ecofeminist alternatives to militarism, insecurity and inhumane weapons, Acronym provides research, ideas and practical strategies to promote and strengthen humanitarian disarmament and security agreements, environmental sustainability and progress for women, peace and security.

The Acronym Institute welcomes donations and is especially grateful to the Joseph Rowntree Charitable Trust (JRCT) for funding our educational and security work, as well as a portion of our work to coordinate advocacy for the UN Treaty on the Prohibition of Nuclear Weapons (TPNW) with ICAN partners, elected representatives and civil society in the UK.

Our grant-funded priorities during 2020 mainly covered nuclear disarmament and new thinking on security, climate and peace objectives, with emphasis on multilateral agreements that reinforce international humanitarian law and the United Nation's Sustainable Development Goals (SDG), particularly relating to SDG 16 on disarmament, SDG 5 on gender equality, SDG 11 on safe cities, and SDGs 13, 14 and 15, relating to climate change, life on land and life in the water.

In conjunction with these priorities, AIDD briefed members of parliaments on various issues relating to our disarmament, security and UN-related work, and made a formal submission to the government's Integrated Review on Security, Defence, Development and Foreign Policy in 2020. In response to calls from Women of Colour Advancing Peace and Security (WCAPS) and other groups and individuals in United States and UK, Acronym also increased our work on SDG 10, relating to reduced inequalities, with greater emphasis on anti-racism, diversity and feminist peace building.

This annual report takes place over a year of Covid lockdowns and cancelled international conferences and meetings, including meetings relating to the 1968 Non-Proliferation Treaty (NPT) and 2017 Treaty on the Prohibition of Nuclear Weapons. AIDD has continued to serve on the International Steering Group (ISG) of the International Campaign to Abolish Nuclear Weapons (ICAN), and engage with diplomats, governments and civil society, including local councils and elected officials. Our ICAN team was extended to include Board member Dr Gari Donn, director of UN House Scotland, as well as Janet Fenton and Dr Rebecca Johnson.

Lord Ramsbotham retired from the Acronym Institute Board of Directors in January 2020, and Marie-Claire Faray was unanimously elected to the Board in June 2020, joining Professor Christine Chinkin (Chair), Ms Nomi Bar Yaacov and Dr Gari Donn.

2. AIDD 2020 work before and after Covid

Before the UK locked down, AIDD's director Rebecca Johnson gave a seminar to over 150 serving officers in British and NATO defence services at the UK's Shrivenham Defence Academy, with emphasis on the growing climate emergency and necessity to reframe UK security and defence policies to tackle 21st century challenges.

This was followed in February with a public presentation at the European Parliament in Brussels on 'The future of nuclear arms control regimes and the security implications for the EU', hosted by the Subcommittee on Security and Defence (SEDE).

Just before the Brussels meeting, AIDD enabled participation of two youth activists, Grace Quin and Kat Ewing, to participate and speak in the ICAN Youth Forum held in Paris. This 3 day event was designed to encourage information exchange and training for young nuclear and climate activists from across Europe. Dr Johnson and Janet Fenton gave talks and lunch-time workshops for activists and students to help them develop local plans, strategies and tactics to take forward disarmament, humanitarian and climate initiatives, including for the TPNW and COP 26.

Following the Covid lockdowns and meeting cancellations, we focussed on being as effective as possible online. As listed in more detail in sections 3 and 4 below, we gave numerous presentations on the TPNW, NPT, the climate emergency, humanitarian security approaches and disarmament, in conjunction with various British and international organisations. These included the InterAction Council and One Young World Intergenerational Dialogue on Nuclear Disarmament, various CND and ICAN meetings with international and governmental participants, FutureFest, the International Panel on Fissile Materials (IPFM), Soka Gakkai International (SGI), Nuclear Information Service, Aldermaston Women's Peace Camp(aign), Chatham House, Friedrich Ebert Stiftung and Extinction Rebellion.

Dr Johnson spoke on security and safe cities as part of the 2020 Salisbury Arts Festival, and participated in the South-South Forum on Sustainability (SSFS7) and Lingnan University on Climate justice and Green New Deals. After signing the WCAPS letter on 'Standing Together Against Racism and Discrimination', Acronym participated in further meetings and facilitated discussions on ICAN's direct engagement. As well as giving a further SSFS7 lecture on 'feminist-antiracist challenges to national security discourses', Dr Johnson participated in an XR Live Chat broadcast on militarism, climate destruction and feminist peace activism, and a Goltune podcast discussions with Iranian-US journalist Sara Jamshidi and NY-based Dr Kathleen Sullivan on how racism, insecurity and climate destruction are embedded in nuclear policies.

In March, AIDD coordinated the last in-person meeting of ICAN's UK partners at the Friends Meeting House, Euston. From then on, we initiated online meetings of ICAN partners every few weeks, including roundtables for Scottish partners working on the TPNW, which were also open to individuals and groups from other parts of the UK. From July we coordinated the ICAN partners network together with UNA-UK, thereby enhancing ICAN's strategic outreach and work related to parliamentary and faith-based advocacy and 'Don't Bank on the Bomb' initiatives. Working collectively with Nuclear Free Local Authorities, Mayors for Peace, Medact, WILPF and other relevant groups and councillors, we collectively increased

the numbers of UK local and county councils who pass resolutions to support and align with the TPNW during the year, adding Glasgow, Edinburgh, Hastings, Norwich, Oxford and Brighton and Hove to Manchester and Leeds which led the way in the previous year.

ICAN partners' major focus in 2020 has been the TPNW's entry into force. Advocacy for the TPNW in Britain intensified during the year, especially after the fiftieth Treaty ratification was received by the United Nations on 24 October, 2020. This milestone provided greater opportunities for engaging with the public, elected representatives and media, as it started the 90 day countdown towards the TPNW coming into full legal force on 22 January 2021.

In support of the SDGs, AIDD continued in 2020 to work closely with the International Action Network on Small Arms (IANSA) in its global outreach and work to implement the Programme of Action on Small Arms and Light Weapons. While serving on the Leadership Team for IANSA, Dr. Natalie Goldring has also contributed to advocacy work, briefing papers and other materials for diplomats. Dr. Goldring represents AIDD in her work on the Arms Trade Treaty and continues to enhance Acronym's work with the United Nations and SDGs, with talks and contributions on ICAN's Cities Appeal, climate justice, safer cities and the disproportionate impact of military-industrial policies on indigenous communities, especially women and girls.

In addition to TPNW publications and media generated through ICAN with our support and input, AIDD publications and media during the year included several articles from Janet Fenton in Bella Caledonia and Peace News, which covered the real meaning of security, divestment from nuclear weapons, why nuclear weapons are a feminist issue, and peace-building in Scotland. Rebecca Johnson had articles published by the Guardian and openDemocracy, and contributed background as well as substantive quotes used in articles from Nature, Associated Press. Analyses by Dr Johnson and Dr Goldring were given extensive coverage in various articles published by In Depth News, the UN-based International Press Syndicate, including on issues covering nuclear and biological weapons developments, military budgets and the gendered use and impact of gun violence and militarism, among other topographical developments. Additionally, Dr Johnson authored a series of short leaflets that were published by XR Peace, covering issues such as militarism's contributions to climate destruction, nuclear weapons, the TPNW, and the UN Secretary-General's Global Ceasefire Initiative. 3. Meetings and events in 2020

This list covers meetings and events that are open to the public with Acronym staff speaking on issues that take forward AIDD areas of work. Unless otherwise specified, due to Covid safety requirements, these meetings were held by zoom or other electronic meeting systems.

5. Institutional Establishment, Staff and Board

The Acronym Institute for Disarmament Diplomacy is a non-profit company 'limited by guarantee', which was established as a security and disarmament research organisation in England and Wales in 1996, No. 3149465.

In accordance with the mission statement and objectives in our Memorandum and Articles of Association, Acronym conducts research and analysis and through meetings, publications and outreach facilitates the fuller participation of civil society and nations in developing and implementing effective measures to eliminate nuclear and other weapons of mass destruction, demilitarise relations between states, promote human security and sustain a healthy environment.

Acronym is constituted to:

 conduct research and obtain, analyse and disseminate ideas and information on peace and human security, disarmament, arms control, non-proliferation, environmental sustainability, women's security, rights and democratic participation,

- gender equality and international law and human rights, including international humanitarian law;
- educate or assist in the education of the public and elected representatives on all relevant aspects relating to debates, policies and negotiations on human, national and international peace and security, including the effects of weapons, security doctrines and disarmament;
- organise meetings and observe or participate in discussions, negotiations, verification and promotion of talks, solutions, negotiations, developments and implementation of agreements, resolutions and treaties in these fields; and
- distribute reports, proceedings, ideas, information and education materials, and to facilitate and assist the distribution of ideas and material collated by other researchers, scientists and activists, whether governmental, intergovernmental and non-governmental, in all relevant aspects relating to human, national and international peace and security issues, as described above.
